1. INTRODUCTION

The purpose of this circular is to provide you with the information regarding the proposed renewal of the general mandates to allot, issue and deal with Shares and to repurchase Shares as well as re-election of retiring directors and to seek your approval of the resolutions relating to these matters at the Annual General Meeting.

LETTER FROM THE BOARD

2. GENERAL MANDATE TO REPURCHASE SHARES

At the annual general meeting of the Company held on 11th June, 2015, a general mandate was given by the Company to the Directors to exercise the powers of the Company to repurchase Shares. Such mandate will lapse at the conclusion of the forthcoming Annual General Meeting of the Company. The Directors propose to seek your approval of the Repurchase Resolution to be proposed at the Annual General Meeting. An explanatory statement as required under the Share Repurchase Rules to provide the requisite information of the Repurchase Proposal is set out in Appendix I hereto.

The general mandate granted pursuant to the Repurchase Resolution shall be exercisable during the period from the passing of the Repurchase Resolution until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company; or
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the laws of Bermuda or bye-laws of the Company to be held; or
- (iii) the date on which the authority set out in this resolution is revoked or varied by an ordinary resolution of the shareholders in general meeting of the Company.

3. GENERAL MANDATE TO ISSUE NEW SHARES

It will also be proposed at the Annual General Meeting two ordinary resolutions (namely ordinary resolutions as referred to in items 6 and 7 of the notice of Annual General Meeting) respectively granting to the Directors a general mandate to allot, issue and deal with Shares not exceeding 20 percent of the total number of Shares in issue as at the date of passing the resolution (i.e. not exceeding 62,328,000 Shares based on the number of issued Shares of 311,640,000 Shares as at the Latest Practicable Date and assuming that such number of issued Shares remains the same as at the date of passing the ordinary resolution) and adding to such general mandate so granted to the Directors the total number of the Shares repurchased by the Company after the granting of the general mandate to repurchase Shares up to 10 percent of the total number of shares of the Company in issue as at the date of passing the Repurchase Resolution.

The general mandate to allot, issue and deal with Shares shall be exercisable during the period from the passing of the ordinary resolution until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company; or
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the laws of Bermuda or bye-laws of the Company to be held; or
- (iii) the date on which the authority set out in this resolution is revoked or varied by an ordinary resolution of the shareholders in general meeting of the Company.

4. RE-ELECTION OF RETIRING DIRECTORS

The Board currently consists of seven Directors, namely Mr. GAN Wee Sean, Mr. Stephen GAN Fock Wai, Mr. GAN Cheng Hooi, Gavin, Ms. GAN Fook Yin, Anita, Mr. Lawrence LEUNG Man Chiu, Ms. Ada WONG Ying Kay and Mr. Arnold IP Tin Chee.

Pursuant to the Bye-laws, Mr. Stephen GAN Fock Wai, Ms. Ada WONG Ying Kay and Mr. Arnold IP Tin Chee, being the Directors longest in office since their last re-election, shall retire by rotation from office at the Annual General Meeting and Mr. GAN Cheng Hooi, Gavin and Ms. GAN Fook Yin, Anita, being new Directors appointed during the year, shall retire at the Annual General Meeting. All the retiring Directors, being eligible, shall offer themselves for re-election.

Ms. WONG Ying Kay, Ada and Mr. IP Tin Chee, Arnold have served as independent non-executive Directors for more than nine years. Pursuant to Code A.4.3 of the Corporate Governance Code, (a) having served the Company for more than nine years could be relevant to the determination of an independent non-executive director's independence and (b) if an independent non-executive director has served more than nine years, his further appointment should be subject to a separate resolution to be approved by Shareholders.

The Company has received respectively from Ms. WONG Ying Kay, Ada and Mr. IP Tin Chee, Arnold a confirmation of independence pursuant to Rule 3.13 of the Listing Rules. Ms. WONG Ying Kay, Ada and Mr. IP Tin Chee, Arnold have not engaged in any executive management of the Group. Taking into consideration of their independent scope of works in the past years, the Directors consider Ms. WONG Ying Kay, Ada and Mr. IP Tin Chee, Arnold to be independent under the Listing Rules despite the fact that they have served the Company for more than nine years. Accordingly, Ms. WONG Ying Kay, Ada and Mr. IP Tin Chee, Arnold shall be subject to retirement by rotation and re-election by way of a separate resolution to be approved by the Shareholders in the Annual General Meeting.

Details of retiring Directors proposed for re-election at the Annual General Meeting are set out in Appendix II to this circular.

5. ANNUAL GENERAL MEETING

On pages 14 to 18 of this circular, you will find a notice convening the Annual General Meeting at which the following resolutions will be proposed:

- an ordinary resolution to grant to the Directors a general mandate to exercise all powers of the Company to repurchase on the Stock Exchange Shares representing up to 10 percent of the total number of Shares in issue as at the date of passing the Repurchase Resolution;
- an ordinary resolution to grant to the Directors a general mandate to authorise the Directors to issue, allot and deal with Shares not exceeding 20 percent of the total number of Shares in issue as at the date of passing such resolution; and
- an ordinary resolution to extend the general mandate which will be granted to the Directors to issue, allot and deal with additional Shares by adding to it the number of Shares repurchased under the Repurchase Proposal after the granting of the general mandate.

6. VOTING BY WAY OF POLL

Pursuant to Rule 13.39(4) of the Listing Rules, all votes at the general meeting of the Company will be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. The Company will announce the results of the poll in the manner prescribed under Rule 13.39(5) of the Listing Rules.

7. ACTION TO BE TAKEN

A proxy form for use at the Annual General Meeting is enclosed with this circular. Whether or not you intend to attend the Annual General Meeting, you are requested to complete the proxy form and return it to the head office and principal place of business of the Company at 11th Floor, 200 Gloucester Road, Wan Chai, Hong Kong not less than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. Completion and return of the proxy form will not prevent shareholders of the Company from attending and voting at the Annual General Meeting if they so wish.

8. RECOMMENDATION

The Directors believe that the Repurchase Proposal, the general mandate for Directors to issue new Shares and the re-election of the retiring directors are all in the best interests of the Company and its shareholders. Accordingly, the Directors recommend that all shareholders of the Company should vote in favour of the relevant resolutions as set out in the notice of Annual General Meeting.

This appendix serves as an explanatory statement, as required by the Share Repurchase Rules, to provide requisite information to you for your consideration of the proposal to permit the repurchase of Shares up to a maximum of 10 percent of the total number of Shares in issue as at the date of passing the Repurchase Resolution.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 311,640,000 Shares.

Subject to the passing of the Repurchase Resolution and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed under the Repurchase Resolution to repurchase a maximum of 31,164,000 Shares, representing not more than 10 percent of the total number of shares of the Company in issue as at the Latest Practicable Date.

2. REASONS FOR REPURCHASE

The Directors believe that the Repurchase Proposal is in the best interests of the Company and its shareholders. Such repurchase may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets and/or earnings per Share of the Company and will only be made when the Directors believe that such a repurchase will benefit the Company and its shareholders.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Directors will only apply funds legally available for such purpose in accordance with its memorandum of association and Bye-laws and the applicable laws of Bermuda. The Companies Act provides that the amount of capital repaid in connection with a share repurchase may only be paid out of either the capital paid up on the relevant shares, or out of the funds of the Company otherwise available for dividend or distribution or the proceeds of a fresh issue of shares made for the purpose. The amount of premium payable on repurchase may only be paid out of either the funds of the Company that would otherwise be available for dividend or distribution or out of the share premium account of the Company.

There might be a material adverse impact on the working capital or gearing position of the Company as compared with the position disclosed in the audited accounts contained in the annual report for the year ended 31st December, 2015 in the event that the power to repurchase Shares pursuant to the Repurchase Proposal were to be exercised in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the power to repurchase Shares pursuant to the Repurchase Proposal to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

5. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will only exercise the powers of the Company to make repurchases pursuant to the Repurchase Proposal in accordance with the Listing Rules and the applicable laws of Bermuda.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their close associates (as defined in the Listing Rules), have any present intention to sell any Shares to the Company or its subsidiaries under the Repurchase Proposal if such is approved by the shareholders of the Company.

No core connected persons (as defined in the Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company or its subsidiaries, or have undertaken not to do so, in the event that the Repurchase Proposal is approved by the shareholders of the Company.

6. TAKEOVERS CODE

If, on the exercise of the power to repurchase Shares pursuant to the Repurchase Proposal, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a shareholder or group of shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, Mr. GAN Wee Sean and Mr. GAN Fock Wai, Stephen together with their respective associates held respectively 94,912,322 Shares and 72,784,799 Shares, representing in aggregate approximately 53.81 percent of the issued share capital of the Company. In the event that the Directors exercised in full the power to repurchase Shares pursuant to the Repurchase Proposal, the shareholdings of Mr. GAN Wee Sean and Mr. GAN Fock Wai, Stephen, together with their associates would be increased to approximately 59.79 percent.

The Directors are not aware of any consequences, which may arise under the Takeovers Code as a result of any repurchases made under the Repurchase Proposal.

In the event that the Repurchase Proposal is exercised in full, the number of Shares held by the public would not fall below 25 percent.

7. SHARES REPURCHASE MADE BY THE COMPANY

The Company had not repurchased any Shares (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.

The following are the particulars of the retiring Directors proposed to be re-elected at the Annual General Meeting to be held on 15th June, 2016:

Mr. Stephen GAN Fock Wai, aged 54, was appointed as an executive director of the Company on 8th October, 1991. He was the Chief Executive Officer of the Company until 21st April, 2008. He has been actively involved in the management of the Group since 1986. He possessed an honorary bachelor degree in food process engineering from Loughborough University of Technology in England. In 2001, he was awarded one of the “2001 Youth Industrial Awards of Hong Kong” by the Federation of Hong Kong Industries. He was also a committee member (Practitioners Board) of the Chinese Medicine Council of Hong Kong from 1999 to 2005. He is a son of the founder, Mr. GAN Geok Eng. Mr. GAN Wee Sean, Chairman of the Company, is a grandson of the founder. Mr. GAN Cheng Hooi, Gavin, executive director of the Company is a son of Mr. GAN Wee Sean. Ms. GAN Fook Yin, Anita, non-executive director of the Company, is a sister of Mr. Stephen GAN. Mr. GAN did not hold any directorship in other listed companies in the past three years. He is a member of remuneration committee of the Company and director in a number of subsidiaries of the Group of the Company. Save as disclosed above, he does not hold any other position of the Company and other companies within the Group.

As at the Latest Practicable Date, Mr. GAN has personal interests and corporate interests of 10,256,879 shares and 62,527,920 shares respectively, representing in aggregate approximately 23.36% of the issued share capital of the Company, within the meaning of Part XV of the Securities and Futures Ordinance (“SFO”). In accordance with the service agreement between the Company and Mr. GAN, he is not appointed for a specific term except that he is subject to retirement by rotation and re-election in accordance with the Company’s Bye-laws. He was entitled to an annual remuneration package including management bonus and housing allowance of HK\$4,844,000 for the year ended 31st December, 2015. There is no agreement as to the director’s fee of Mr. GAN and his director’s fee will be determined by the board by reference to the prevailing market conditions and subject to the shareholders’ approval at the Annual General Meeting. Save as disclosed above, he does not have any relationship with any other directors, senior management, substantial or controlling shareholders of the Company.

Save as disclosed above, Mr. GAN has confirmed that there are no other matters that need to be brought to the attention of the shareholders of the Company in connection with his re-election and no other information that should be disclosed pursuant to rule 13.51(2)(h) to (v) of the Listing Rules.

Mr. GAN Cheng Hooi, Gavin, aged 35, was appointed as an executive director of the Company on 23rd September, 2015. He joined Hoe Hin Pak Fah Yeow Manufactory, Limited (“HHPFY”), a wholly-owned subsidiary of the Company, in October 2007 and is now the business development manager of HHPFY responsible for developing new and existing markets as well as brand building. Prior to joining HHPFY, he worked in different industries including market research, information technology and management consultancy. He obtained a bachelor degree in management from Royal Holloway University of London. Mr. Gavin GAN is a son of Mr. GAN Wee Sean, who is the chairman, chief executive officer, executive director and substantial shareholder of the Company and the eldest grandson of the founder, Mr. GAN Geok Eng. Mr. GAN Fock Wai, Stephen, executive director of the Company and Ms. GAN Fook Yin, Anita, non-executive director of the Company, are respectively the son and daughter of the founder, Mr. GAN Geok Eng.

Mr. Gavin GAN did not hold any directorship in other listed companies in the past three years. Save as disclosed above, he does not hold any other position of the Company and other companies within the Group.

Save as disclosed, Mr. Gavin GAN does not have any relationship with any other directors, senior management, substantial or controlling shareholders of the Company. As at the Latest Practicable Date, he does not have any interest in the shares of the Company within the meaning of Part XV of the SFO.

The Company has entered into a service agreement with Mr. Gavin GAN for a period of three years commencing from 23rd September, 2015 which is subject to retirement by rotation and re-election at the annual general meeting in accordance with the bye-laws of the Company.

Mr. Gavin GAN was entitled to an annual remuneration package as business development manager of HHPFY including management and discretionary bonuses of HK\$710,000 for the year ended 31st December, 2015. He was also entitled to receive a director fee of HK\$10,000 for the year ended 31st December, 2015 which is subject to approval of the Board by reference to prevailing market conditions and the approval of shareholders of the Company at the Annual General Meeting.

Save as disclosed above, Mr. Gavin GAN has confirmed that there are no other matters that need to be brought to the attention of the shareholders of the Company in connection with his re-election and no other information that should be disclosed pursuant to rule 13.51(2)(h) to (v) of the Listing Rules.

Ms. GAN Fook Yin, Anita, aged 47, was appointed as a non-executive director of the Company on 23rd September, 2015. She joined Rena Creative Products Ltd. (“RENA”) since 1999 and is now the chief executive officer of RENA. Prior to joining RENA, she served as chairman of Chancy Company Ltd. Now she also serves as an executive director of Rena Creative Services Ltd., which has three Hello Kitty Cafes in both Hong Kong and Macau. Ms. Anita GAN has leadership and extensive managerial experience in financial, strategic, capital allocation and human resources. She obtained a bachelor degree in mathematics and management from King’s College, University of London. Ms. Anita GAN is a daughter of the founder, Mr. GAN Geok Eng and a sister of Mr. GAN Fock Wai, Stephen, who is an executive director and substantial shareholder of the Company. Mr. GAN Wee Sean, Chairman of the Company, is a grandson of the founder. Mr. GAN Cheng Hooi, Gavin, executive director of the Company, is a son of Mr. GAN Wee Sean.

Ms. Anita GAN did not hold any directorship in other listed companies in the past three years. Save as disclosed above, she does not hold any other position of the Company and other companies within the Group.

Save as disclosed, Ms. Anita GAN does not have any relationship with any other directors, senior management, substantial or controlling shareholders of the Company. As at the Latest Practicable Date, she has personal interest in 1,190,280 shares of the Company within the meaning of Part XV of the SFO.

The Company has entered into a letter of appointment with Ms. Anita GAN for a period of three years commencing from 23rd September, 2015 which is subject to retirement by rotation and re-election at the annual general meeting in accordance with the bye-laws of the Company.

Ms. Anita GAN was entitled to receive a director fee of HK\$31,000 for the year ended 31st December, 2015 which is subject to approval of the Board by reference to prevailing market conditions and approval of shareholders of the Company at the Annual General Meeting.

Save as disclosed above, Ms. Anita GAN has confirmed that there are no other matters that need to be brought to the attention of the shareholders of the Company in connection with her re-election and no other information that should be disclosed pursuant to rule 13.51(2)(h) to (v) of the Listing Rules.

Mr. Arnold IP Tin Chee, aged 53, was appointed as an independent non-executive director of the Company in September 2004. He is a graduate of Trinity College, Cambridge University, and qualified as a chartered accountant in 1988. Between 1989 and March 1997, he worked for Standard Chartered Asia Limited and was a director of Yuanta Securities (Hong Kong) Limited thereafter until January 2001, specialising in a range of corporate finance and advisory activities for companies based in Hong Kong and China. He is a director of Altus Capital Limited where he is involved in the supervision and management of corporate finance and advisory work for companies in Hong Kong and in advising on private equity and property investments in Asia. Mr. IP's work focuses on fund raising for listed and unlisted companies, and management of real estate investment funds. He is chairman of the management company which acts as manager of Saizen REIT, a real estate investment trust listed on the Singapore Stock Exchange. He is also an independent non-executive director of Pioneer Global Group Limited and Sam Woo Construction Group Limited, companies listed on the Stock Exchange. Save as disclosed, Mr. IP did not hold any directorship in other listed companies in the past three years. Mr. IP is a member of audit committee, remuneration committee and nomination committee. Save as disclosed above, he does not hold any other position of the Company and other companies within the Group.

Mr. IP is appointed for a term of two years until 30th September, 2016 and subject to retirement by rotation and re-election provisions in the Bye-laws. He was entitled to receive a director fee of HK\$113,000 for the year ended 31st December, 2015 which is subject to approval of the Board by reference to the prevailing market conditions and the approval of shareholders of the Company at the Annual General Meeting.

Mr. IP does not have any relationship with any other directors, senior management, substantial or controlling shareholders of the Company. Mr. IP does not have any interest in the shares of the Company within the meaning of Part XV of the SFO.
