### **POSITIVE PROFIT ALERT**

This announcement is made pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the SFO.

Based on preliminary assessment of the management accounts of the Group, the Board wishes to inform the shareholders of the Company and potential investors that the Group is expected to record a significant increase in consolidated net profit attributable to the owners of the Company to the region of approximately HK\$100.0 million for the year ended 31 December 2023, as compared to the published consolidated net profit attributable to the owners of the Company of HK\$30.0 million for the same corresponding period in 2022.

**Shareholders of the Company and potential investors should exercise caution when dealing in shares of the Company.**

This announcement is made by Pak Fah Yeow International Limited (the “Company”, together with its subsidiaries, the “Group”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “SFO”).

Based on preliminary assessment of the management accounts of the Group, the board of directors (the “Board”) of the Company wishes to inform the shareholders of the Company and potential investors that the Group is expected to record a significant increase in consolidated net profit attributable to the owners of the Company to the region of approximately HK\$100.0 million for the year ended 31 December 2023, as compared to the published consolidated net profit attributable to the owners of the Company of HK\$30.0 million for the same corresponding period in 2022. The Board considers that such expected increase in net profit is mainly attributable to significant increase in sales revenue of the healthcare business segment, despite a higher unrealised fair value loss of investment properties recognised in 2023.
